## **IMPORTANT**

Enrolment form must be duly completed. Placement to the respective programmes will only be confirmed upon receipt of payment. Please take note of the following policies and criteria:

### **Withdrawal Policy:**

1. Withdrawal request must be made in writing and no other mode of informing will be accepted.
2. For company-sponsored participants, the withdrawal request must be written by the authorised representative of the company.
3. Registered participants who do not show up for the course will be considered as “Withdrawal without notice” and SeraphCorp reserves the right to charge a penalty of 100% of the course fee.

### **Refund Policy:**

1. Course fees paid to SeraphCorp are refundable based on the following conditions:

### **Eligibility for Funding:**

1. Must be Singaporean or Permanent Residents of Singapore.
2. Must maintain a minimum attendance of 75%, completed all assessment activities and participate in our Post Course Evaluations.

### **For SkillsFuture Credit:**

1. For disbursements made to Training Providers, application of claims may be made within 30 days before course start date.
2. For disbursements made to individuals, application of claims may be made 30 days before course start date to 90 days after.
3. Individuals is responsible to ensure that they have sufficient SkillsFuture Credit balance for the course.

### **Postponement or Deferment of Course:**
